Subject: - Inviting quotations for procurement of Buprenorphine tablets 0.4mg.

Chandigarh SACS intends to procure Buprenorphine tablets for its peripheral OST Centers and You are invited to submit your most competitive quotation for the supply of Buprenorphine tablets as per Technical Specifications given below: -

1	Tablet Buprenorphine 0.4 mg	Each uncoated sublingual tablet contains Buprenorphine Hydrochloride IP equivalent to Buprenorphine 0.4 mg	Blister pack of 10 tablets and 10 blister packs per box.	26200 tablets
2	The shelf life of the drug should be 3 years from the date of manufacture			
3	The manufacturer/supplier shall submit an undertaking of conformance to the rules and regulations laid down in the narcotics Drugs and Psychotrop9ic Substances Act 1985 and its amendments, and the Drugs and Cosmetic Act 1940 and the rule thereof. The undertaking should be accompanied with all relevant documents and certifications.			
4	The manufacturer/supplier shall submit certificate of GMP (Good manufacturing Practice) and Market Standing Certificate.			
5	The manufacturer/supplier shall submit the proof of a valid product license congruent to the Drug and Cosmetics Act 1940.			
6	The Buprenorphine sublingual tablets should be tasteless and odourless.			
7	The Buprenorphine sublingual tablets should fulfill the general and/or individual drug requirements as per Indian Pharmacopoeia 2018 with addendum 2019.			
8	All blister packs of Buprenorphine sublingual tablets must indicate the dates of manufacturing and expiry.			
9	All consignments must arrive at the final consignee point with a remaining shelf life of at least five-sixths (5/6ths) of the total stipulated shelf life at the time of manufacture.			

Quotation requirements: -

1)The rate of taxes to be charged (if any) must be clearly mentioned.

2) BID PRICE

- The contract shall be for the full quantity as described above as per lowest quoted rate. Corrections, if any, shall be made by crossing out, initialing, dating and rewriting.
- All duties, taxes and other levies payable shall be included in the total price.

- c) The rates quoted by the bidder shall be fixed and shall not be subject to adjustment on any account.
- d) The price shall be quoted in Indian Rupees only.
- e) Each bidder shall submit only one quotation.

3) VALIDITY OF QUOTATION

Quotation shall remain valid for a period of not less than 90 days after the deadline date specified for submission.

4) EVALUATION OF QUOTATION

The CSACS shall evaluate and compare the quotations determined to be substantially responsive i.e. which

- A) Are properly signed and
- B) Confirm to the terms and conditions and specifications.
- D) GST/TIN number should be mentioned on letter head.

5) AWARD OF CONTRACT

- A) The CSACS will issue the supply order to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.
- B) Notwithstanding the above, the purchaser reserves the right to accept or reject any quotation and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.

6) **IN CASE OF DELAY OF SUPPLY:** - Liquidated damages will be charged @ 0.5% per week subject to maximum deduction of 10% of contract price.

7) TDS/GST will be deducted as per Rules, the vendor shall submit copy of PAN card & GST number for this purpose.

8) You are requested to provide your offer latest by 2:00 P.M on 20/04/2023 in sealed envelopes, preferably by Registered Post super scribing "QUOTATIONS FOR SUPPLY OF BUPRENORPHINE 0.4mg for OST Centres due on 20/04/2023" on the envelop. Envelopes should be labeled. **Unlabeled envelopes are straight way rejected.**

9) Quantity can be increased or decreased as per requirement.

10) Quotation received after the due date and with condition shall not be accepted.
